

Device for digitizing materials

1 Abstract

Photometric stereo is a technique used to extract three-dimensional (3D) shape information of various materials and examine how these materials interact with light. This document serves as a defensive publication for a product designed to scan materials, analyzing their 3D shape, and their reflection, transmission, or emission of light. A key function of the product is to determine the parameters of a "Spatially Varying Bidirectional Reflectance Distribution Function" (SVBRDF).

The materials for scanning can be anything that manipulates light in some way, including but not limited to hot steel slabs, liquids, fabrics, leather, plants, rocks, skin, hair, and photoluminescent materials. The scanner deploys diverse light forms, each varying in form and/or spectral distribution, to illuminate the material. Utilizing a range of light sources mitigates any limitations that would be present if relying solely on a single light type. [AM15]

2 Description

The scanner comprises several optional components, including:

1. One or more cameras that capture the light's interaction with the material. The use of multiple cameras enhances data availability and allows for a more accurate 3D model of the object through stereophotogrammetry. By integrating high frequency detail provided by the normal map derived from photometric stereo, an enhanced 3D representation of the object can be achieved. The cameras can either be fitted with a color filter array (CFA) or be monochrome, potentially with a filter wheel for superior quality images.
2. Broadband point light sources, such as white LEDs, are typically used due to their affordability and ease of mathematical modeling. Despite these benefits, they may not perform well with

glossy materials with low roughness, and hard shadows can cause artifacts unless properly managed. This can be mitigated by using them in greater number.

3. Colored or spectrally variable point light sources, such as colored LEDs, lasers, or broadband light sources with filters, can provide useful information about the photoluminescence of the material. An inexpensive yet effective method to produce colored light involves controlling the incidence angle of broadband light onto a prism, grating or a similar object, resulting in a "rainbow" of light, from which a specific wavelength band can be selected by an optical slit.
4. Linear light sources, either broadband/white or colored/spectrally variable, can significantly improve the quality of scans for highly glossy materials. [UTSY10]
5. Area light sources can replace point light sources to aid with materials exhibiting low roughness. A potentially more effective, albeit challenging, alternative could be to use point light sources behind a medium that scatters their light, creating a blurred, overlapped lighting effect conducive to accurate normal calculation for mirror-like materials. 6. An area light source can be placed behind the material to measure translucency or transparency.
7. All light sources can be paired with (linear/circular) polarizers to discern the specular and diffuse reflection of a material. Additionally, translucency and transparency can be separated using polarizers, as light waves directly passing through the material maintain polarization while scattered waves alter their polarization.
8. Other 3D scanning technologies, such as structured light scanners or stereophotogrammetry (when using multiple cameras), can be used to capture a 3D representation of the material.
9. An optical rangefinder can help adjust the focus of the camera lenses electronically or manually.
10. Special lenses, like a tilt-shift lens, can be employed for scanning flat materials, allowing the image plane of a camera sensor to be parallel to the material, even if they are not physically aligned.
11. To minimize stray light, the device's interior can be coated with a material that absorbs light well, such as black velvet. The scanner can be shielded by a cover or an enclosure to prevent the influence of ambient light. Alternatively, the scanning process can be performed in a dark environment.
12. The light sources and cameras can be moved around the material, either physically or by using mirrors or other optical elements. Alternatively, the material itself can be moved while the light sources and cameras stay stationary. For instance, the material can be placed on a rotating platform or conveyor belt.
13. A mobile device may be constructed by attaching the light sources to the multiple legs of the device, akin to a multi-legged tripod. A camera would be centrally mounted, facing downwards, and additional side-mounted cameras can be added to provide multiple viewing angles. This design would be both flexible and portable, with collapsible legs for ease of storage and transport.
14. An alternative approach would involve attaching the scanner to a gantry. This could provide one to three-dimensional movement and more degrees of freedom for rotation. This capability would be especially useful for scanning larger materials or objects, where multiple scans across different areas are required. These scans can be subsequently merged to generate a

comprehensive scan of the entire object. The same could be achieved by mounting the object to be scanned on a device with similar functionality, such as a tiltable rotary table, which is similar to devices used in 5-axis CNC mills.

15. To mitigate the effects of any luminance instability from the light sources, a device can be directly illuminated to measure the intensity of the light. This data can then be used to adjust for any light source variations during the scanning process. Alternatively, a spectrometer can be used to classify the spectral distribution of the light sources, which can further help to compensate for any instability in this distribution.
16. Depending on the usage scenario and the available infrastructure, the scanner can be powered either by batteries or directly from an outlet. This flexibility allows the scanner to be used in a variety of settings and reduces the dependency on a constant power source.

3 Methodology

The proposed scanning process involves several steps:

1. Calibration: Calibration is performed to ascertain the camera's intrinsic properties (focal length, principal point, and lens distortion parameters) and extrinsic properties (position and orientation in relation to the material). Furthermore, the position and brightness distribution of the light sources are also calibrated.
2. Illumination and Capturing: The material is then illuminated by the light sources, and the cameras capture the resulting interaction between light and material. This process can be repeated with different lighting configurations to provide more comprehensive data about the material.
3. Post-Processing: The captured images are processed to extract various material properties. The specific algorithms used will depend on the types of light sources and the properties of the material. The outcome of this step could include a normal map of the material's surface, its SVBRDF parameters, or a 3D model.
4. Result Analysis: Finally, the processed data can be analysed or visualised, and used for various applications such as quality control, material design, or computer graphics rendering.

4 Capture and Processing Details

1. The scanning process involves capturing images of the reflection of light emitted by one or more light sources. A group of cameras simultaneously captures these reflections. The light sources can be modulated to produce a pattern or gradient in the reflected light. If there are multiple cameras and multiple light sources, the maximum total number of images taken for a single scan (assuming the material and camera remain stationary) equals the number of cameras times the number of light sources. This total is further multiplied by the number of filters if a filter wheel is employed.
2. The images captured are processed by a computer, with the computations executed either on the CPU or GPU for efficient processing. The choice between the two will largely depend on the specific requirements of the computations and the capabilities of the hardware.

3. The images may be transmitted to the computer directly from the cameras or, in the case of standalone cameras with onboard storage, the images can be first stored within the camera and then transferred to the computer for further processing.
4. Light sources can be toggled on and off using a variety of methods. One such method employs MOSFETs paired with daisy-chained shift registers controlled by a microcontroller or computer. This system has the advantage of scalability. Other forms of communication, like I2C between the microcontroller and an LED controller, are also possible. Yet another alternative is to use one dimmable constant current controller for each LED. This allows for the implementation of multiple dimming methods such as analog, PWM, and shunt FET dimming. The specific dimming method can be dynamically chosen via software.

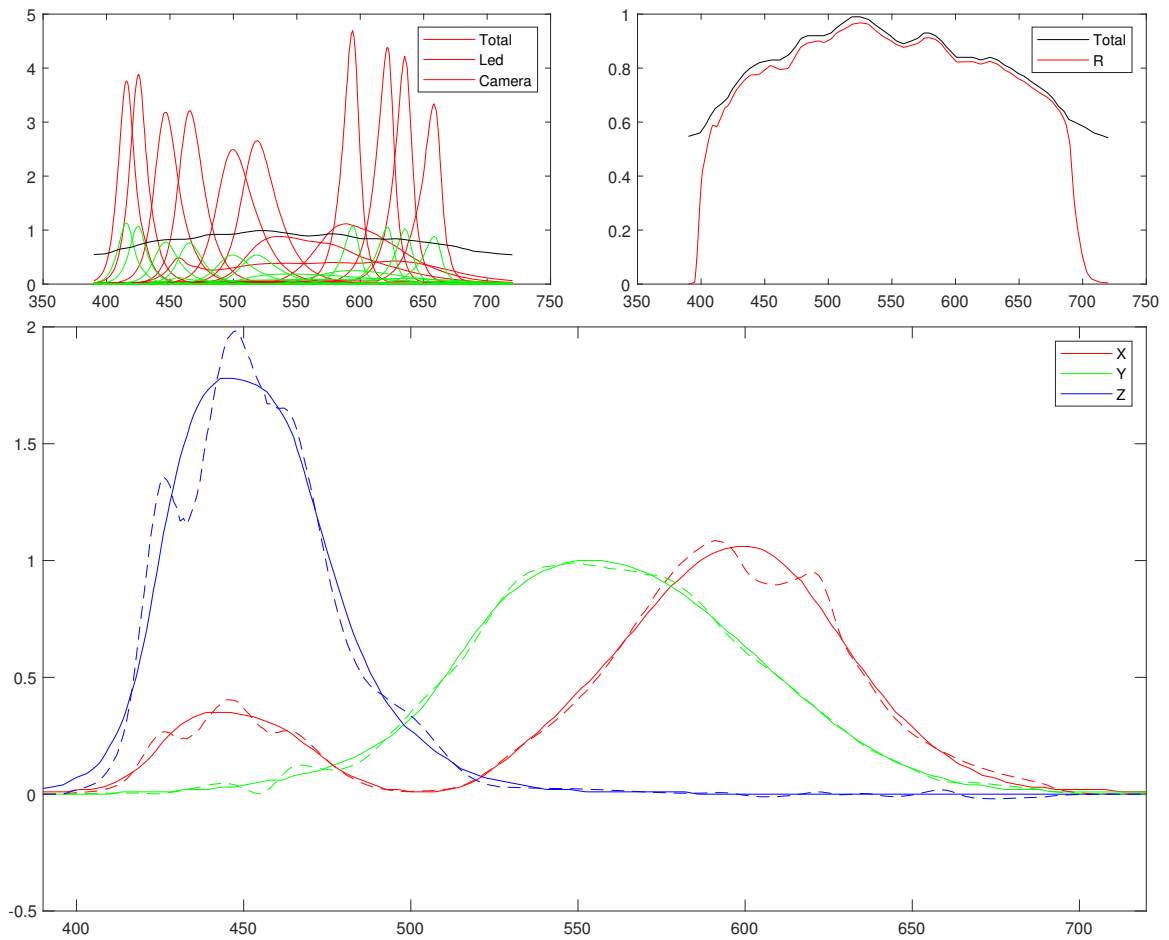


Figure 1: Multispectral to RGB charts (top left: specular distribution of light sources, top right: specular response of camera, bottom: reference XYZ response combined with theoretical spectral response of merged images taken in combination with each led)

5. Multispectral images can be acquired using multiple colored light sources. High color accuracy can be achieved by multiplying the acquired samples per pixel with a pre-calculated matrix. See figure 1.
6. Normals of the material can be calculated using the images of the specular reflection. By comparing these normals with those calculated from the diffuse reflection of the broadband or colored light sources, subsurface scattering parameters can be estimated. Once the normals from the specular reflections are obtained, solving for the subsurface scattering parameters directly (like via gradient descent) can be executed, but this may require more computational resources. The above details shed light on the in-depth process of capturing and processing images for material scanning. The scanner design, coupled with this comprehensive methodology, allows for accurate capture and analysis of a wide range of material properties.

5 Future Scope and Potential Extensions

While the current focus is on the primary objectives of the project, there are several potential enhancements and additional applications that could be explored in the future:

1. **Portability:** Minimizing the weight of the scanner could transform it into a handheld device, offering enhanced convenience and portability. This could broaden its usage scenarios, such as field studies or on-site analysis.
2. **Advanced Imaging:** The acquisition and separation of multiple reflections from various light sources in a single image could be achieved by using cameras fitted with polarization or color filters. This could involve employing a filter wheel or Color Filter Array (CFA). Having multiple polarized and/or colored light sources in different positions would enhance this setup. A beam splitter could be utilized for efficiency, allowing multiple cameras to capture images from the same perspective. The characteristics of the beam splitter could be adjusted based on the polarization or color of the light, possibly utilizing thin-film filters.
3. **Digital Material Conversion:** The algorithm used for processing the acquired data could be adapted to convert existing digital materials into other formats. This could be achieved by rendering these materials in a virtualized version of the scanner setup. For instance, the properties of a Disney BRDF for a material could be calculated and converted even if the digital version is in another format.
4. **GAN Network Enhancement:** A Generative Adversarial Network (GAN) could be trained on the resulting textures to improve perception. Ideally, the perceptual loss would be cal-

culated on rendered images, which would require gradient backpropagation through the renderer. This could be achieved directly, through analytical approximations, or via trained neural networks to attain a good approximation.

5. **Simplified Scanner:** A simpler scanner design with fewer light sources and potentially without polarization could be realized. To handle the reduced data, a neural network like a U-Net could be trained to predict the different textures. The network training could ideally be done using the results from a more complex scanner as ground truth. The input during training could be renders of the ground truth or a subset of images captured by the larger scanner.
6. **Data Interpolation for Glossy Materials:** For highly glossy materials, normals and roughness values can be interpolated for pixels that did not contain enough reflected light to calculate the textures accurately. This can be done by setting a minimum specularity (F_0) for the material and checking if the measured values align with a high enough roughness value that sufficiently illuminates the pixels. If a lower roughness value is necessary for the measured results, interpolation might be necessary. Once the areas for interpolation are identified, this can be done by examining the nearest patches of normals that did reflect enough light in any image for accurate calculation.

These potential extensions underline the versatility and scalability of the scanner system, paving the way for future advancements and wider applications in material scanning and imaging.

6 Applications and Impact

The proposed device offers broad applicability spanning across various domains. Its primary function lies in digitizing real-world materials and computing the parameters that describe these materials based on the Disney Bidirectional Reflectance Distribution Function (BRDF).^[BB] This ability to accurately capture and recreate the physical characteristics of a material digitally opens up new possibilities in fields such as computer graphics, virtual reality, and industrial design.

Moreover, the device's versatility extends beyond material digitization, making it an effective tool in various other fields. In the medical domain, it could potentially be used for skin scanning, providing crucial insights into skin health and abnormalities. For industrial applications, the device could serve as an optical inspection tool for surfaces such as steel slabs, aiding in quality control and defect detection.

7 Acknowledgements and Legal Considerations

The concepts and ideas presented here have been inspired by various research publications and other sources not all of which have been cited explicitly. This document serves as an informal exposition of a material scanner's concept rather than a formal scientific publication.

While the ideas listed here are open for anyone to utilize and adapt, it's crucial to be aware of existing patents that could potentially be infringed upon if all these ideas are implemented collectively. There is a plethora of patents related to the method of photometric stereo, some with very broad claims. Therefore, before implementing these ideas, thorough patent research and legal consultation should be undertaken to ensure compliance with all relevant intellectual property laws.
